## Application for Processor or Affiliate Membership

### PROCESSOR MEMBERSHIP

**FULL MEMBERSHIP** is open to individuals, firms and/or corporations that manufacture, process or distribute milk or dairy products in North Carolina or Virginia. Full Processor member companies in good standing may annually nominate a director to serve on the board of directors who shall have one full vote.

Processor membership dues are based on a schedule of dues of .00035 of the total volume dollar sales in North Carolina and/or Virginia for the previous month, payable in advance on a monthly basis.

Dues are billed and payable on a monthly basis. Maximum annual dues are \$7,500, minimum dues are \$500.

We hereby apply for **Full Membership** in CVDPA and agree to pay membership dues for the current calendar year in accordance with our annual company sales.

**JUNIOR MEMBERSHIP** is open to individuals, firms and/or corporations that manufacture, process or distribute pasteurized fluid or powdered milk or ice cream in North Carolina or Virginia. Junior Processor member companies in good standing may annually nominate a director to serve on the board of directors who shall have 1/5 vote.

Dues are \$400 per year, payable in the amount of \$200 semi-annually.

We hereby apply for **Junior Membership** in CVDPA and agree to pay membership dues for the current calendar year in accordance with the fee schedule here set forth.

### AFFILIATE MEMBERSHIP

**Affiliate Membership** is open to processors who are not eligible for and elected to processor membership, and who manufacture and process milk or dairy products distributed from other states into North Carolina or Virginia. Affiliate Members shall be entitled to attend meetings of the Association but not be eligible to vote, serve on the Board of Directors or serve as an officer of the Association.

Dues are \$500 per year, payable in advance on an annual basis.
